Sir,

I am directed to refer to your application for grant of Continuation of Recognition of MBBS degree (150 seats) awarded by M.G.R. Medical University in respect of the students being trained at Melmarvathur Adhiparashakti Institute of Medical Sciences and Research, Melmarvathur, Tamil Nadu and to say that your college was assessed by the Assessors appointed by MARB to conduct physical assessment during the final MBBS practical examination on 27.03.2023. The report of virtual assessment is not available with UGMEB.

2. The above assessment report alongwith the data available on AEBAS and HMIS including CCTV footage was considered in Under Graduate Medical Education Board (UGMEB) and certain deficiencies were noted. The same were communicated to the college authorities vide UGMEB's letter dated 24.05.2023 for compliance.

3. In response to the above, Melmarvathur Adhiparashakti Institute of Medical Sciences and Research, Melmavathur, Tamil Nadu has submitted their reply vide letter dated 02.06.2023 with regard to the deficiencies pointed out by UGMEB in its letter dated 24.05.2023. Subsequently, an opportunity of the personal hearing was also given to the college authorities on 13.06.2023.

4. After hearing the college authorities and careful consideration of the facts and compliance, it has been decided by the UGMEB that Melmarvathur Adhiparashakti Institute of Medical Sciences and Research, Melmarvathur, Tamil Nadu is granted one year Continuation of Recognition of MBBS qualification. However, they shall apply afresh for Continuation of Recognition in 2024.

5. Accordingly, the approval of the competent authority in UGMEB is hereby conveyed for grant of **CONTINUATION OF RECOGNITION FOR ONE YEAR** for MBBS degree for 150 students, awarded by M.G.R. Medical University in respect of the students being trained at Melmarvathur Adhiparashakti Institute of Medical Sciences and Research, Melmarvathur, Tamil Nadu.


